## Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement

By signing this document you will waive certain legal rights, including the right to sue.

**PLEASE READ CAREFULLY**

To: Sitting Tree School and Nature Programs (the "School") and its Directors, Officers, Employees, Representatives, Agents and Volunteers (collectively, the "Releasees");

### Assumption of Risks:

I understand that the Programs involve various activities comprising children's educational and recreational programs, including indoor and outdoor activities, (the "Programs") which may involve the risk of serious injury and/or death.

### Release of Liability, waiver of claims and indemnity agreement:

In consideration of the School providing the Programs, and agreeing to allow the Minor to participate in the Programs, the receipt and sufficiency of which consideration is hereby acknowledged, I hereby individually and also as a parent and guardian of the Minor, agree as follows:

1. To waive any and all claims that I have or may in the future have against the Releasees;
2. To release the Releasees from any and all liability for any loss, damage, injury or expense that I may suffer or that my next-of-kin may suffer as a result of my minor child's participation in Programs, due to any cause whatsoever, including negligence or breach of contract or breach of any statutory or other duty of care on the part of the Releasees;
3. To hold harmless and indemnify the Releasees from any and all liability for any property damage or personal injury sustained by any third party, resulting from the Minor's participation in Programs; and
4. To be responsible for and to indemnify the School and its successors and assigns against all financial obligations of the Minor arising in respect of such Minor's registration with the School.
5. This Agreement will be effective and binding upon my heirs, next-of-kin, executors, administrators and assigns, in the event of my death or incapacity.

### Acknowledgements

In entering into this Agreement I am not relying on any oral or written representations or statements made by the Releasees, other than what is set forth in this Agreement. I acknowledge that the registration by me of the Minor in the School and his/her participation in Programs is purely voluntary.
